2. Copyright.

If you submit content to the OCACW newsletter, you grant OCACW non-exclusive, royalty-free, reprint rights, while retaining your own copyrights. In addition, if you grant OCACW electronic rights, said newsletter submissions may be displayed on OCACW's web site for an unspecified length of time; or displayed in rotation with other submissions.
